



ADDENDUM TO AFTERCARE & MENTORING AGREEMENT FOR RECENT ADDICTS

By your own admission, you have used drugs within the last week. Jesus said, "If your right eye causes you to sin, pluck it out and cast it from you; for it is more profitable for you that one of your members perish, than for your whole body to be cast into hell" (Matthew 5:29). The point is that we are engaged in a life and death battle for where we will spend eternity and we must fight, we must take drastic measures to eradicate sinful habits from our lives before they kill us. Sin wants to rule us. Satan wants to sift us like wheat. But Jesus prays that the faith of his saints will not fail! By God's grace, you can do all things through Christ who strengthens you! Toward that end, you agree as follows:

1. You understand you are on house arrest and, except for approved activities, you will remain in the house to which you are assigned.
2. You agree not to leave the house except for work, worship or pre-approved activities at pre-approved locations (listed below). Anywhere you desire to go outside of work, you must have a pre-approved mentor with you (listed below). You agree to submit your work schedule as soon as you have it, in advance, to a mentor and not to deviate from that schedule (even if called in) without first seeking the approval of a mentor.
3. In the presence of a mentor, you agree to allow a mentor to change the password to all existing email or social media accounts OR to terminate them in the presence of a mentor, and to limit your use to accounts that have been established by and will be monitored by a mentor.
4. Inside the house, all electronic devices (including your phone) are to be held by and used only in the presence of a mentor. Inside, you will be allowed the use of your phone for up to 30 minutes to call pre-approved contacts (listed below). This means you agree to turn your phone in when you arrive and to ask for it back only when you are using it within the allotted time in their presence or when you are leaving for pre-approved activities.
5. You agree not to tamper at any time with any of the electronic devices or online accounts provided for your usage in any way. You further agree not to ask to use devices belonging to others whether inside or outside of the ministry.
6. You agree that you are not allowed money in your possession unless pre-approved for specific purposes and accounted for with a receipt.
7. You understand and agree that the ministry will hold funds on your behalf from which it will pay your program fees, buy groceries and pay any other expenses.
8. **Cancellation Clause:** This addendum may be terminated by either party, with or without cause. If the Addendum is terminated by YOU, without having violated any rules, any unused funds held by the ministry for you will be released to you or used to pay for your expenses wherever you choose to go as long as you leave immediately. If the Addendum is terminated by the ministry due to a specific violation, however, you understand and agree that any funds held by the ministry will become the property of the ministry and you will be asked to leave immediately.
